The notice shall contain a statement that the person has the right to demand that the evidentiary hearing or meeting be held in open session. This paragraph and par. (f) do not apply to any such evidentiary hearing or meeting where the employee or person licensed requests that an open session be held. (b)

Considering employment or performance evaluation data of any public employee over which the school district exercises responsibility, specifically for the purpose of preliminary consideration of teacher contract layoff and staff reduction in hours, and consideration of the issuance of preliminary notices of layoff and reduction in hours, and considering personal histories of specific persons, which, if discussed in public, would be likely to have a substantial adverse effect upon the reputation of any person referred to in such histories.
